1. Welcome prayer

LB-V led the meeting in prayer. Andrew Hall, newly appointed Parent Governor, was welcomed to the meeting.

2. Apologies for absence

Jane Fraser, Nicole Amil & Fr John Smethurst sent their apologies, sanctioned by the meeting.

3. Correspondence since last meeting

Procedural matters

4. Declaration of Business Interests

Governors who were previously absent signed the Business Interest Register.

5. Previous minutes & matters arising

The minutes were approved unanimously & signed. No matters arising.

6. Urgent business from the Chair and Headteacher

School management, monitoring and evaluation

7. OFSTED Action Group report

SC reported on the last meeting as in the minutes on the Google Drive. He highlighted the Karen Gannon report and the Actions This Term Review, both on the Governors Google Drive with the minutes at *Governors/Ofsted* + *Standards/28 Nov 17 meeting*

8. SEND report

The SEND report, written by Tamsin Corline, SENDCo, was handed out. This will be discussed at the next meeting when Governors have had time to read it.

9. Governor visit report from AK

AK reported on his visit to meet with SH, English Lead, as in his report on the Google Drive at Governors/LGB/17-18 LGB meetings/05 Dec 17.

Finance

10. Update

CJ explained she would be attending a CAST Finance Administrators meeting the next day & expected the briefing to include how to prepare budget monitoring reports for Governors. The new finance system is gradually bedding in, but there have been many problems along the way which have taken up a great deal of her finance admin time. Once the system is fully operational the finance aspects of her admin role should take up less time.

11. Feedback from 27 Nov finance meeting

JF & AB attended & felt it was a positive session with CAST staff appreciating the difficulties of reducing the budget in this school under the current circumstances. They presented the budget reduction proposals as in the Recovery Plan and highlighted the impact these reductions would have on the school. CAST will inform the school of their decision in January.

Ideas for promoting the school to increase future pupil numbers were also discussed e.g. inviting other preschools to use the grounds including the forest school and inviting families and childminders to events.

Spirituality

12. Spirituality Committee report

LB-V reported on the meeting on 14 Nov 17, the first to be held since the LGB reinstated committee meetings. The meeting focussed on community relations, particularly with the two catholic parishes served by the school. A volunteer has been found through AK's link with the Abbey Road parish (Church of the Assumption of Our Lady) to mend the mosaic and friendship bench. AB said she is very keen to have the mosaic repaired & reinstated; LS agreed as the Section 48 inspection mentioned that the school does not look particularly Catholic.

Safeguarding

13. Update on safeguarding issues

Torbay Council recently conducted a safeguarding audit. AP, JF, AB & SG attended the meeting with the Torbay Council Safeguarding Lead and the Chair of the Independent Board. The visiting officials were satisfied that strong safeguarding processes and procedures were in place in the school. The school was able to raise the issue of the gaps in external services e.g. CAMHS having such a long waiting list that children referred by the school cannot be seen, & CIN meeting minutes not being sent in a timely manner so not held on file in school. The same issues had been raised with the visiting officials by other school.

It was suggested that the school produce parent and child friendly versions of the safeguarding policy; the school asked for assistance with this.

It was agreed that the audit would be repeated in the autumn term.

AB commented that three safeguarding audits had recently been held in the school – Torbay Council, CAST & NSPCC.

14. Keeping Children Safe in Education Part 1

Governors who were previously absent were asked to sign the sheet confirming they have read the DfE document Keeping Children Safe in Education Part 1. Louise Adams suggested adding "and understanding my responsibilities" to the statement at the head of the staff and Governors' signing sheet next time.

15.Completion of SG2, 3 & 4

AP & AB agreed to complete these, for return to CAST.

16. Update on Health & Safety issues

OFSTED monitoring visit

17. Feedback from OFSTED inspection 30 Nov – 01 Dec

AB asked SG for her comments; she responded

- Overall pleased that the outcome was adequate progress
- Initially the inspection was very challenging, but things settled down by Friday afternoon by when working relations were good and issues were discussed thoroughly
- There were no surprises
- The verbal feedback was positive (written report yet to be received)
- HMI were fully satisfied with safeguarding in the school; the minor issue from the July monitoring visit of some missing paperwork has been resolved
